

## **Big 5 - Tasmania & King Island Promotion Terms and Conditions of Entry**

### **General**

1. Information on how to enter and prizes form part of the Terms and Conditions of Entry. Entry into this competition is deemed acceptance of these Terms and Conditions.
2. To the extent of any inconsistency between these Terms and Conditions and any other reference to this competition, these Terms and Conditions prevail.

### **Who can enter**

3. Subject to the clauses below, entry is open to all residents of Australia (excluding South Australia) who have fulfilled the requirements set out below ('**Eligible Entrants**'). Entrants must be over the age of 18, as of the date of entry.
4. Employees, and their immediate families, of the Promoter, associated agencies and companies, contractors or individuals are not eligible to enter this competition. Immediate family means any of the following: spouse, ex-spouse, defacto spouse, child or step child (whether natural or by adoption), parent, step parent, grandparent, step grandparent, uncle, aunt, niece, nephew, brother, sister, step brother, step sister or 1st cousin.

### **How to enter**

The subscription provides access to a range of membership benefits. Annual members also receive a physical welcome pack of Tour Tee products valued at approximately \$50. ### **Number of Entries permitted**

11. The competition commences on **20/01/2026 at 12:00 AM AEST** and closes **01/03/2026 at 06:00 PM AEST (“Promotional Period”)**. All times noted in these Terms and Conditions are local times, based on the location of the Promoter. If any draw date falls on a public holiday, as defined in the state of the Promoter, that draw will be conducted on the next business day. Entries must be received by the Promoter prior to the competition close date and time.
